Terms and Conditions:

1. Customer accounts are subject to Heatcraft New Zealand Pty Ltd (Heatcraft) Standard Terms and Conditions.
2. The Heatcraft coolcard™ will only be issued to Heatcraft trade customers (customers) who have an active account with Heatcraft and have provided an ABN number.
3. The coolcard will be used for identification purposes only and has no credit linked to it.
4. To be eligible for a Heatcraft coolcard, a cardholder must be enrolled by their employer.
5. Cardholders must not provide false or misleading information to Heatcraft and must not use another cardholder's card or alter or disclose any details of other cardholders.
6. It is the customer's responsibility to notify Heatcraft immediately when a change of employee status has occurred so that their coolcard can be cancelled.
7. The Heatcraft coolcard is for use by the authorised cardholder only and must not be lent or given to unauthorised persons.
8. The coolcard must be presented to Heatcraft branch staff for scanning at the time of purchase.
9. If more than one account is linked to the coolcard, the cardholder must nominate the correct account. It is the cardholder's responsibility to provide this information. If the wrong account is nominated, Heatcraft will not be responsible for invoicing the wrong account.
10. First time users will be asked to provide a unique password to activate their card. They will only be asked to confirm their password if Heatcraft is uncertain of their identity.
11. If an order is placed by phone, the coolcard number and password must be provided.
12. If the cardholder forgets his/her password, their authorising manager will be asked to confirm the identity of the cardholder.
13. The cardholder is responsible for the security of their coolcard. If your card is lost or stolen, please call Heatcraft on (+64 9) 259 2206 and provide your card number, contact details and password. Once your information is confirmed, Heatcraft New Zealand will cancel the card and provide you with a replacement.
14. The coolcard is valid for use in all Heatcraft branches and joint ventures in Australia and New Zealand. Heatcraft will only accept active coolcards and will not be responsible if a transaction was conducted by an ex-employee of your company if the ex-employee presents an active coolcard card and Heatcraft has not been notified.
15. Heatcraft coolcards are non-transferable and are not redeemable for cash.
16. Coolcard Reports will be available for the primary coolcard holder and will include transaction dates and times, coolcard card numbers and transaction values.
17. Heatcraft reserves the right to change/modify the Terms & Conditions from time to time, or withdraw the coolcard program without prior notice.
18. By using your coolcard you are agreeing to these Terms & Conditions.
